5/29 Birthday Sweepstakes 2016 Official Rules

- **1. Sponsor**: The Idaho College Savings Program 2016 5/29 Birthday Sweepstakes ("Sweepstakes") is sponsored by the Idaho College Savings Program ("IDeal" or "Sponsor"). IDeal's offices are located within the Idaho State Treasurer's Office at 700 W. Jefferson St., Suite E228, Boise, Idaho 83702.
- **2. Eligibility:** Participation is open only to individual legal residents of the State of Idaho who are at least 18 years of age and have a valid Social Security number or tax identification number. Otherwise eligible participants with a mailing address that is a P.O. Box must have a valid physical address in Idaho that is not a P.O. Box. Void outside of the State of Idaho, and where prohibited or restricted by local law. Employees, officers and directors and their immediate families (parents, children, siblings, and spouse), and members of their household (whether or not related) of IDeal, the Idaho College Savings Program Board, and any FINRA member are not eligible to participate in the Sweepstakes. The Sweepstakes may only be entered in or from the State of Idaho. Entries originating from any other jurisdiction are not eligible for the Sweepstakes.
- **3. How to Enter/Entry Period:** Individuals are automatically entered into the Sweepstakes if they are the mother or father of a baby delivered on May 29, 2016 (12:00 am to 11:59 pm, MDT) or closest to that day (each an "IDeal Baby") at a Participating Hospital and meet the eligibility criteria described above. - **4. Odds:** The odds of winning cannot be determined in advance. One (1) winner at each Participating Hospital will be selected based on the closest time the IDeal Baby was born to 12:00 am MDT on May 29, 2016 at each Participating Hospital in accordance with these Official Rules. IDeal will work with each Participating Hospital to determine the winner. Odds of winning depend upon the number of babies born on May 29, 2016 at Participating Hospitals. If no baby is born at a Participating Hospital on May 29, 2016, the baby born after that date, but closest to May 29, 2016, will be chosen as an alternative IDeal Baby.
- **5. Prizes:** Each winner will receive Five Hundred and Twenty-Nine U.S. Dollars (\$529) in the form of a contribution to the winner's IDeal account (the "Prize"). All potential winners are subject to eligibility verification by IDeal, whose decisions are final and binding in all matters related to the Sweepstakes. In the event the winner does not have an existing IDeal account, the winner will be required to complete documentation necessary to open an IDeal account, including an enrollment form with investment instructions. All suits or claims brought in connection with this Sweepstakes must be brought in a state or federal court in Idaho. Taxes and fees, if any, are the sole responsibility of the winner(s). By entering the Sweepstakes, entrants fully and unconditionally agree to be bound by these Official Rules and the decisions of IDeal, which will be final and binding on all matters relating to the Sweepstakes, and warrant that (s)he is eligible to participate in the Sweepstakes and to grant permission for the submission materials to be posted publicly, including on the Internet. Release:** Each entrant agrees, except where prohibited by law, to release and discharge, hold harmless and indemnify the State of Idaho, IDeal, its employees, agents and representatives, officers and officials and their immediate families, successors and assigns, and all others associated with the development and execution of this Sweepstakes, from: any and all tax liability that may be imposed or associated with receipt or use of the Prize; and from and against any and all claims, actions, proceedings, and liability for any damages, expenses, fees, injury or losses sustained in connection with the receipt, ownership, use or misuse of the Prize or while traveling to, preparing for, or participating in any Sweepstakes related activity; and from any and all claims, actions, proceedings, and liability for any damages, expenses, fees, injury or losses sustained in connection with the receipt, ownership, use or misuse of the submission materials or the photograph of an IDeal Baby.
