

**2019 LEARNING QUEST BLUE CREW SWEEPSTAKES**  
**AMERICAN CENTURY INVESTMENTS**  
**OFFICIAL RULES**

**ELIGIBILITY:** This sweepstakes (“Sweepstakes”) is offered only to legal residents of the United States including its commonwealths, territories and possessions (collectively referred to herein as “states”) who are eighteen (18) years of age or older (except in the case of legal residents of certain states/territories where the legal age of majority is greater than eighteen (18) years of age, such legal age of majority) at the time of entry.
