

**LEARNING QUEST SEASONAL CONTEST
AMERICAN CENTURY INVESTMENTS
OFFICIAL RULES**

ELIGIBILITY: This contest (“Contest”) is offered only to those who are 18 years of age or older. Unless specifically excluded as set forth in these Official Rules, any person who has provided the information required by these Official Rules and has entered the Contest within the timelines specified below shall be eligible to win the grand prize.
