\$100K in 100 Days Official Rules
MO Money Sweepstakes

NO PURCHASE NECESSARY. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. ALL ENTRIES MUST BE SUBMITTED ONLINE BY 6/4/2020 at 9 AM, CENTRAL TIME. ENTRANTS/WINNERS MUST BE 18 YEARS OF AGE ON OR BEFORE FEBRUARY 26, 2020, THE TIME OF THE SWEEPSTAKES LAUNCH.

1. **How to enter:** Complete all required fields and click the **Submit** button. ALL ENTRIES MUST BE RECEIVED BY 6/4/2020 AT 9:00 AM, CENTRAL TIME. Only online entries will be accepted; no mechanically reproduced, illegible, incomplete, forged, or altered entries will be accepted. Limit: one entry per person. Note: Entrants are eligible to obtain two additional entries (automatically entered by the sponsor) by following @MOST529 on Facebook and Twitter. Sponsor, specified below, is not responsible for late, lost, misdirected, or incorrect entries.
2. **Selection of winner:** Prize winner(s) will be selected at various intervals throughout the month of May 2020 with the final drawing taking place on June 4, 2020: Twenty-five (25) \$529 contributions drawn on May 15, 2020; Ten (10) \$1,000 contributions drawn on May 29, 2020; and Fifteen (15) \$5,029 contributions drawn on June 4, 2020. On all drawing dates, winners will be selected through random draw, between 9:00 and 11:59 AM in random drawings from among all eligible entries received by representatives of Sponsor, whose decisions are final on all matters relating to this Sweepstakes. Once a winner is selected, that winner is removed from the sweepstakes pool and will not be eligible to participate/win in the subsequent drawings. Odds of winning depend upon number of eligible entries received. Winner will be notified by telephone and via email, and, if winner does not already have a MOST 529 account (the "529 account"), the winner will be required to complete documentation necessary to open a 529 account, including investment instructions. The winner will be the account owner and, at their discretion, they can allocate the prize across one or more beneficiary accounts. Prize may be awarded to an alternate winner if: 529 account is not established and in good order within 14 days after contacting winner; winner is not eligible to open the 529 account; winner does not provide investment instructions; prize notification email is returned as undeliverable and three attempts to contact winner live by telephone are unsuccessful (voicemails will be left; the winner will have 3 days to return the message and accept the prize).
3. **Prizes:** - Twenty-five (25) \$529 contributions drawn on May 15, 2020; Ten (10) 1,000 contributions drawn on May 29, 2020; and Fifteen (15) \$5,029 contributions drawn on June 4, 2020, paid directly to the winner's 529 account (existing account or to-be-established 529 account). The remaining balance will be awarded at sponsorships in May. Allow 8–12 weeks for delivery of Prize. Sponsor responsible only for delivery of Prize; not responsible for Prize utility or otherwise.
