

## Official Drawing Rules

**NO PURCHASE IS NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED BY LAW.**

**PICTURE MY PRIDE AND JOY DRAWINGS BEGIN ON AUGUST 26, 2024, AND END ON SEPTEMBER 30, 2024.**

- 1. Eligibility:** Participation is open only to Eligible Individuals. An Eligible Individual means a legal resident of the State of North Dakota who is at least 18 years of age as of the date of entry, has a social security number or tax identification number, and is a current owner of one or more College SAVE Plans. Employees, officers, and directors and their immediate family members (parents, children, siblings, and spouse) and members of their household (whether or not related) of the College SAVE Plan (the "Sponsor" or "College SAVE"), Bank of North Dakota, Ascensus College Savings Recordkeeping Services, LLC, Ascensus Broker Dealer Services, LLC, and any other FINRA member are not eligible to participate in the College SAVE Picture My Pride and Joy Drawings ("Drawings", each a "Drawing") identified below. The Drawings may only be entered in or from the State of North Dakota. Entries originating from any other jurisdiction are not eligible for the Drawings.
- 2. How to Enter:** The Picture My Pride and Joy Drawings are open between August 26, 2024, and September 30, 2024. Eligible Individuals may enter the random Drawings online at [collegesave4u.com/prideandjoy](http://collegesave4u.com/prideandjoy) or by mailing a postcard or letter, which includes the entrant's name, address, and telephone number, to "College SAVE - College SAVE Picture My Pride and Joy Drawings" c/o Bank of North Dakota, College SAVE, PO Box 5509, Bismarck, ND 58506-9978 for receipt by midnight on September 30, 2024. Only one (1) entry per College SAVE account is permitted. Entries by Eligible Individuals that are timely received are considered "Eligible Entries." The Sponsor is not responsible for lost, late, corrupted, or misdirected entries, whether due to technical or computer malfunctions or otherwise. Eligible Individuals who submit an entry are known as "Entrants."
- 3. Random Drawing/Odds:** Eleven (11) winners will be selected at random from the Drawing of Eligible Entries. The odds of winning depend upon the number of Eligible Entries received by the Sponsor for inclusion in each Drawing.
- 4. Prizes:** One (1) grand prize winner selected by the Sponsor will receive a \$529 contribution to his/her College SAVE 529 account ("Grand Prize"). If the Grand Prize winner has more than one beneficiary, unless otherwise indicated, the Grand Prize will be deposited into the -01 account on file. Ten (10) additional winners selected by the Sponsor will receive a \$100 Shutterfly Electronic Gift Card ("Prize") (the Prize and Grand Prize collectively referred to as the "Prizes"). All potential winners are subject to eligibility verification by the Sponsor, whose decisions are final and binding in all matters related to the Drawings. An Entrant shall not be deemed a winner of any Prize unless and until the Entrant's eligibility has been verified and the Entrant has been notified that verification is complete. The Prizes are non-transferable. The Sponsor is responsible only for delivery of the Prizes and is not responsible for the Prizes utility or otherwise. The Drawings do not take into account a winner's personal circumstances or other factors that may be

important in making investment decisions. Investment returns are not guaranteed, and the winner could lose money by investing in College SAVE. The winner should consult his or her own tax advisor about tax implications, if any, associated with contributions and/or withdrawals from a College SAVE account. The Prize may be considered income, and any and all taxes associated with a Prize are the responsibility of the winner.

- 5. Notification:** The eleven (11) winners will be notified by October 13, 2024, via telephone, email, or U.S. mail. The winners will work directly with Bank of North Dakota to receive their Prize. The Prize may be awarded to an alternate winner (selected in a random drawing from among all remaining Eligible Entrants) if (i) the Prize notification letter is returned as undeliverable, or (ii) three (3) good faith attempts to contact the winner live by telephone are unsuccessful; or (iii) no response is received to the notification e-mail, if any or (iv) it is determined that the Entrant does not meet the eligibility requirements in Paragraph 1 above. No more than the stated number of Prizes will be awarded. In the event that production, technical, seeding, programming, or any other reasons cause more than the stated number of Prizes as set forth in these Official Drawing Rules to be available and/or claimed, the Sponsor reserves the right to award only the stated number of Prizes by a random drawing among all legitimate, un-awarded, eligible Prize claims.
- 6. Miscellaneous and Conditions of Participation:** The Drawings are void where prohibited or restricted by law, and are subject to all applicable federal, state, and local laws and regulations. Except where prohibited by law, all issues concerning the construction, validity, and enforcement of these Official Drawing Rules, or the rights and obligations of the Entrant and Sponsor, shall be construed and governed by the laws of the state of North Dakota without regard to conflicts of law. All suits or claims brought in connection with the Drawings must be brought in a state or federal court of appropriate jurisdiction located in North Dakota. By entering a Drawing, Entrants fully and unconditionally (i) agree to be bound by these Official Drawing Rules and the decisions of the Sponsor, which will be final and binding on all matters relating to the Drawing, and (ii) warrant that (s)he is eligible to participate in the Drawing. The Sponsor reserves the right to disqualify any Entrant if these Official Drawing Rules are not followed, change, alter, or amend these Official Drawing Rules or alter, modify, suspend, or terminate a Drawing, as necessary, in its sole discretion, to ensure the fair administration of the Drawings or to comply with applicable law. The Drawings are not a recommendation to invest in College SAVE.
- 7. Release:** Each Entrant agrees, except where prohibited by law, to release and discharge, hold harmless, and indemnify the Sponsor, its employees, agents, contractors and representatives, officers and directors and their immediate families, successors and assigns, and all others associated with the development and execution of the Drawings, from and against any and all tax liability that may be imposed or associated with receipt or use of the Prize, and from and against any and all claims, actions, proceedings, and liability for any damages, expenses, fees, injury, or losses sustained in connection with the receipt, ownership, use, or misuse of the Prize or for any damages, expenses, fees, injury, or losses sustained while traveling to, preparing for, or participating in any Drawing-related activity.
- 8. Publicity:** Except where prohibited by law, by entering a Drawing or by winning, Entrants grant to the Sponsor the right to publicize the entrant's name, photograph, image, likeness, voice, statements, and biographical information in all manner and media, worldwide, in perpetuity, for

advertising, trade, and promotion purposes without compensation and without opportunity for review.

- 9. Limitations of Liability:** The Sponsor, its employees, agents, contractors and representatives, officers and directors and their immediate families, successors and assigns, and all others associated with the development and execution of a Drawing shall have no responsibility or liability for (i) any incorrect or inaccurate information, whether caused by Entrants, printing errors, or by any of the equipment or programming associated with or utilized in a Drawing; (ii) technical failures of any kind, including, but not limited to, malfunctions, interruptions, or disconnections in telephone lines or network hardware or software; (iii) unauthorized human intervention in any part of the entry process or a Drawing; (iv) technical or human error which may occur in the administration of a Drawing; or (v) failed, incomplete, garbled, jumbled, corrupted, or delayed computer transmissions which may limit an individual's ability to enter a Drawing, including any injury or damage to entrant's or any other person's computer relating to or resulting from entering a Drawing or downloading any materials related to a Drawing.
- 10. Entrant's Personal Information:** Information collected from entrants will be maintained by the Sponsor and its representatives in accordance with applicable federal and state consumer privacy laws, rules, and regulations.
