## **Official Drawing Rules**

## NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED BY LAW.

- 1. Eligibility: Participation is open only to individual legal residents of the State of North Dakota who are at least 18 years of age as of the date of entry, and have a social security number or tax identification number. Employees, officers and directors and their immediate families (parents, children, siblings, and spouse) and members of their household (whether or not related) of the College SAVE Plan (the "Sponsor" or "College SAVE"), Bank of North Dakota, Ascensus College Savings Recordkeeping Services, LLC, Ascensus Broker Dealer Services, Inc., and any other FINRA member are not eligible to participate in the Pride of Dakota Drawing identified below. The Drawing may only be entered in or from the State of North Dakota. Entries originating from any other jurisdiction are not eligible for the Drawing.
- **2. How to Enter:** Individuals who enter into the drawing from September 9, 2021 through midnight on December 5, 2021 will be eligible. Limit per Drawing: One (1) entry per family.
- **3. Random Drawing/Odds:** One (1) winner will be selected on or about December 5, 2021. Odds of winning a Prize from the Drawing depend upon the number of eligible New or Existing accounts when the Drawing closes at midnight on December 5, 2021.
- 4. Prizes: One (1) winner selected by the Sponsor will receive Five Hundred Twenty-Nine U.S. Dollars (\$529.00) in the form of a contribution to the winner's account in College SAVE, a Section 529 college savings plan offered by the Bank of North Dakota (the "Prize"). All potential winners are subject to eligibility verification by the Sponsor, whose decisions are final and binding in all matters related to the Drawing. An entrant is not a winner of any Prize unless and until the entrant's eligibility has been verified and the entrant has been notified that verification is complete. The Prize is nontransferrable. The Sponsor is responsible only for delivery of the Prize; not responsible for Prize utility or otherwise. The Drawing does not take into account a winner's personal circumstances or other factors that may be important in making investment decisions. Investment returns are not guaranteed and the winner could lose money by investing in College SAVE. - **5. Notification:** The winner will be notified by telephone or U.S. mail, and the Prize will be deposited directly into the winner's College SAVE account. In the event the winner does not have an existing College SAVE account, the winner will be required to complete documentation necessary to open a College SAVE account, including an enrollment form with investment instructions. All suits or claims brought in connection with the Drawing must be brought in a state or federal court in North Dakota. Taxes and fees, if any, are the sole responsibility of the winner. By entering a Drawing, entrants fully and unconditionally agree to be bound by these Official Drawing Rules and the decisions of the Sponsor, which will be final and binding on all matters relating to the Drawing, and warrant that (s)he is eligible to participate in the Drawing. The Sponsor reserves the right to disqualify any entrant if these Official Drawing Rules are not followed, change, alter, or amend these Official Drawing Rules or alter, modify, suspend, or terminate a Drawing, as necessary, in its sole discretion, to ensure the fair administration of the Drawing or to comply with applicable law. The Drawing is not a recommendation to invest in College SAVE.
- 7. Release: Each entrant agrees, except where prohibited by law, to release and discharge, hold harmless, and indemnify the Sponsor, its employees, agents and representatives, officers and directors and their immediate families, successors and assigns, and all others associated with the development and execution of the Drawing, from any and all tax liability that may be imposed or associated with receipt or use of the Prize, and from

and against any and all claims, actions, proceedings, and liability for any damages, expenses, fees, injury, or losses sustained in connection with the receipt, ownership, use, or misuse of the Prize or while traveling to, preparing for, or participating in any Drawing-related activity.

- **8.
