

Official Rules - Nevada College Savings Month \$529 Scholarship Giveaway

Deadline: September 30, 2015

1. No purchase necessary to win.
2. Sponsor: The Board of Trustees of the College Savings Plans of Nevada.
3. Eligibility Requirements: Open to Nevada residents with children aged 13 or younger who enter by midnight September 30, 2015. Entries are accepted online at ssga.upromise529.com/giveaway. Employees of the State Treasurer's Office or Ascensus Broker Dealer Services, Inc. providing direct support to the College Savings Plans of Nevada, the Board of Trustees of the College Savings Plan of Nevada, or employees of advertising and promotional agencies and others who provide support to the College Savings Plans, and their immediate family members and members of their households, are NOT ELIGIBLE to participate. The College Savings Month \$529 Account Giveaway begins on September 1, 2015, and closes at midnight September 30, 2015. Sponsor reserves the right to verify eligibility at any time, and reserves the right not to award prizes to ineligible applicants.
4. How to Enter: Nevada residents with children aged 13 years or younger may enter by visiting ssga.upromise529.com/giveaway and completing the online entry form. Parents may complete only one entry per eligible child. Neither the Sponsor nor Ascensus Broker Dealer Services, Inc. and its affiliates "Ascensus," nor the State of Nevada Treasurer's Office assumes any responsibility for lost, stolen, late, redirected, or damaged applications.
5. Selection of Winners: Twenty winners (20 total) will be selected via a random drawing from all eligible entrants who enter online prior to midnight, September 30, 2015. Five winners will be selected each Wednesday throughout the month of September for a total of 20 winners (drawings will be held September 9th, 16th, 23rd, and 30th). Each selected winner will be invited to submit a photo while holding a paper with their education dream, as well as the hashtag #NevadaSaves, to be shared on social media. Winners will be announced to the public following the verification and notification of Winners. The results of the drawing, and all decisions of the Sponsor as to the administration of the College Savings Month \$529 Account Giveaway and the prize awards, are final and binding in all aspects. Winners will be notified of their selection by phone, email, and/or postal mail. The State of Nevada Treasurer's Office, the Board of Trustees of the College Savings Plans of Nevada, and Ascensus are not responsible for, and shall not be liable for, late, lost, misdirected, or unsuccessful efforts to notify Winners.
6. Prizes: Twenty (20) Winners will receive a \$529 contribution into an SSgA Upromise 529 Plan (the "Plan") college savings account. If the Winner has an existing eligible account, the \$529 award will be contributed into that account. If a Winner does not have an existing eligible account, the Winner must supply the Plan with the appropriate information to establish an account in the Plan. Funding for the College Savings Month \$529 Account Giveaway accounts will be provided by the Board of Trustees of the College Savings Plans of Nevada; no taxpayer dollars are used to fund scholarship prizes. The Nevada College Savings Month \$529 Account Giveaway does not take into account Winner's personal circumstances or other factors that may be important in making investment decisions. Investment returns are not guaranteed and Winner could lose money by investing in the Plan. The Nevada College Savings Month \$529 Account Giveaway is not a recommendation to invest in the Plan.

Prizes may be awarded to alternate Winners (selected in a random drawing from among all remaining eligible entrants) if (i) the Plan account documentation is not returned in good order within fourteen (14) days after mailing to Winner; (ii) the Winner is not eligible to open a Plan account; (iii) the Winner does not provide investment instructions; (iv) the prize notification letter is returned as undeliverable; or (v) three (3) good faith attempts

to contact the Winner "live" by telephone are unsuccessful (no messages will be left). All prizes are awarded "AS IS" WITHOUT WARRANTY OF ANY KIND, EXPRESS OR IMPLIED, INCLUDING WITHOUT LIMITATION WARRANTIES OF FITNESS FOR A PARTICULAR PURPOSE.

8. Odds of Winning: Odds of winning depend on the number of entries received online before midnight, before each drawing period.

9. Privacy Policy: Any information provided to the Nevada State Treasurer's Office through participation in the Nevada College Savings Month \$529 Account Giveaway will be used only in accordance with the State of Nevada Treasurer's Office Privacy Policy.

10. General Terms and Conditions: The Nevada College Savings Month \$529 Account Giveaway is void where prohibited or restricted by law. By participating in the Nevada College Savings Month \$529 Account Giveaway, all participants and their parents/guardians agree to be bound by all the Official Rules of the Nevada College Savings Month \$529 Account Giveaway and the decisions of the Sponsor, which shall be final. All federal, state, and local laws and regulations apply. Neither the Sponsor, nor the State of Nevada Treasurer's Office staff, nor any other State of Nevada employee, nor Ascensus Broker Dealer Services, Inc., is in any way responsible or liable for damage, loss or injury resulting from human error, altered, illegible, late, lost, or misdirected applications, events beyond their control, or acceptance and use of a prize.
