

## Official Rules - Nevada College Savings Day \$529 Account Giveaway

Deadline: May 31, 2019

1. No purchase necessary to win.
2. Sponsor: The Board of Trustees of the College Savings Plans of Nevada ("Board" or "Sponsor").
3. Eligibility Requirements: Open to Nevada residents at least 18 years of age as of the date of entry who have children aged 13 or younger. Entries are accepted online at [ssga.upromise529.com/giveaway](http://ssga.upromise529.com/giveaway) and must be submitted by midnight May 31, 2019. The Board, employees of the State of Nevada Treasurer's Office (the "Treasurer"), Ascensus Broker Dealer Services, LLC and its affiliates (together, "Ascensus"), or SSGA – State Street Global Advisors Inc., providing direct support to the SSGA Upromise 529 Plan (the "Plan"), the Sponsor, advertising and promotional agencies and others who provide support to the Plan, and their immediate family members and members of their households, are NOT ELIGIBLE to participate.

Sponsor reserves the right to verify eligibility at any time, and reserves the right not to award prizes to ineligible applicants.

4. How to Enter: Eligible entrants (as described above) may enter by visiting [ssga.upromise529.com/giveaway](http://ssga.upromise529.com/giveaway) and completing and submitting the online entry form by midnight May 31, 2019. The Nevada College Savings Day \$529 Account Scholarship Giveaway ("Giveaway") begins on May 1, 2019, and ends at midnight May 31, 2019. Parents may complete only one entry per eligible child. Neither the Sponsor, Ascensus Broker Dealer Services, LLC, nor the Treasurer assumes any responsibility for lost, stolen, late, redirected, or damaged applications.

5. Selection of Winners: One (1) winner in total will be selected via a random drawing from all eligible entrants who enter online prior to midnight, May 31, 2019. The random drawing will be held no later than June 7, 2019. The winner will be announced to the public following the verification and notification of the winner. The results of the drawing, and all decisions of the Sponsor as to the administration of the Giveaway and the prize awards, are final and binding in all aspects. Winner will be notified of their selection by phone, email, and/or postal mail. Neither the Treasurer, the Board, nor Ascensus are not responsible for, and shall not be liable for, late, lost, misdirected, or unsuccessful efforts to notify winners.

6. Prizes: The winner will receive a \$529 contribution into an SSGA Upromise 529 Plan (the "Plan") college savings account. If the winner has an existing eligible Plan account, the \$529 award will be contributed into that account. If a winner does not have an existing eligible account, the winner must supply the Plan with the appropriate information to establish an account in the Plan. Funding for the Giveaway accounts will be provided by the Sponsor; no taxpayer dollars are used to fund scholarship prizes. The Giveaway does not take into account winner's personal circumstances or other factors that may be important in making investment decisions. Investment returns are not guaranteed and winner could lose money by investing in the Plan. The Giveaway is not a recommendation to invest in the Plan.

7. Notification of Winners: Prizes may be considered income. Winners are urged to consult a tax advisor regarding tax consequences of any prize in light of the winner's individual circumstances.

All prizes will be awarded. Prizes not claimed within thirty (30) days after the date on which the notification was made will be forfeited and awarded to the next alternative winner, in accordance with these Official Rules. Prizes may be awarded to alternate winners (selected in a random drawing from among all remaining eligible entrants) if (i) the Plan account documentation is not returned in good order within fourteen (14) days after mailing to winner; (ii) the winner is not eligible to open a Plan account; (iii) the winner does not provide investment instructions; (iv) the prize notification letter is returned as undeliverable; or (v) three (3) good faith attempts to contact the winner "live" by telephone are unsuccessful (no messages will be left).

All prizes are awarded "AS IS" WITHOUT WARRANTY OF ANY KIND, EXPRESS OR IMPLIED, INCLUDING WITHOUT LIMITATION WARRANTIES OF FITNESS FOR A PARTICULAR PURPOSE.

8. Odds of Winning: Odds of winning depend on the number of entries received online before midnight, May 31, 2019.

9. Privacy Policy: Any information provided to the Treasurer through participation in the Giveaway will be used only in accordance with the State of Nevada Treasurer's Office Privacy Policy.

10. General Terms and Conditions: The Giveaway is void where prohibited or restricted by law and is subject to all applicable federal, state, and local laws and regulations. Except where prohibited by law, all issues concerning the construction, validity and enforcement of these Official Rules, or the rights and obligations of the entrant and Sponsor, shall be construed and governed by the laws of the state of Nevada without regard to conflicts of law. By participating in the Giveaway, all entrants and their parents/guardians agree to be bound by all the Official Rules of the Giveaway and the decisions of the Sponsor, which shall be final. All federal, state, and local laws and regulations apply. Neither the Sponsor, nor the Treasurer's staff, nor any other State of Nevada employee, nor Ascensus is in any way responsible or liable for damage, loss or injury resulting from human error, altered, illegible, late, lost, or misdirected applications, events beyond their control, or acceptance and use of a prize. Winner assumes liability for injuries caused or claimed to be caused by participating in the Giveaway or by receipt of any prize. Sponsor reserves the right to suspend or terminate the Giveaway or any entrant's participation in the Giveaway should unauthorized human intervention or other causes beyond Sponsor's control affect the administration, security, or proper play of the Giveaway or Sponsor otherwise becomes (as determined in its sole discretion) incapable of running the Giveaway as planned.

Entrants who violate these Official Rules, tamper with the operation of the Giveaway, or engage in any conduct that is detrimental or unfair to Sponsor, the Giveaway or any other individual (in each case as determined in Sponsor's sole discretion) are subject to disqualification from entry into the Giveaway. Sponsor reserves the right to lock out any person whose eligibility is in question or who has been disqualified or is otherwise ineligible to enter the Giveaway. Sponsor reserves the right to change, alter, or amend these Official Rules or to alter, modify, suspend, or terminate the Giveaway, as necessary, at its sole discretion, to ensure the fair administration of the Giveaway or to comply with applicable law.

11. Certificate and Consent: As a condition of being awarded any prize, winners will be required to execute and deliver to Sponsor a signed Certificate of Eligibility and Acceptance of these Official Rules and a Release of Liability Form. By entering, the entrant agrees that no claim relating to losses or injuries shall be asserted against the Treasurer, the Sponsor, the State of Nevada, the Nevada College Savings Trust Fund, Ascensus, or any of their affiliates, directors, officers, shareholders, employees, or agents. By accepting a prize, winner agrees to and shall be

deemed to release and hold harmless the Nevada College Savings Trust Fund, the Sponsor, the Treasurer and staff, Ascensus, and any of their affiliates, directors, officers, shareholders, employees, or agents against any and all losses, damages, rights, claims and actions of any kind resulting from or arising in connection with the Giveaway or acceptance, delivery, misdelivery, possession or use of or inability to use any prize, including without limitation, personal injuries, death and property damage, rights of publicity or privacy, defamation or portrayal in a false light, whether intentional or unintentional, and whether under a theory of contract, tort theory (including negligence), warranty, or other theory. If winner does not have existing eligible account, winner shall be required to provide the Sponsor with all necessary beneficiary information (i.e., beneficiary name, address, date of birth, and Social Security number) to open the SSGA Upromise 529 account.

12. Use of Winner's Information: By entering the Giveaway, winner grants the Sponsor the right to publicize the entrant's name, photograph, image, likeness, voice, statements, and biographical information for advertising, trade, and promotion purposes without compensation and without opportunity for review. All submissions may be subject to public display, including, without limitation, electronic display via a website.
