

ABLE CT PRIVACY NOTICE

ABLE CT respects your right to privacy and wants you to know how we handle your personal information. ABLE CT collects personal information, such as name, address, telephone number, Social Security Number, Taxpayer ID, or email address (collectively, "Personal Information") about you from the following sources:

- Information you provide to us on a voluntary basis when you conduct business with ABLE CT, its agents, or subcontractors whether online, through the mail, or over the phone;
- Information received from the Social Security Administration, the Internal Revenue Service, other state or federal programs, or state agencies; and
- Information received from third-party payment processors to which you have made contributions or withdrawals.

Access by our employees, contractors, agents, and subcontractors to your Personal Information is only on a need to know basis on the understanding that it is confidential business information. ABLE CT does not disclose Personal Information to third parties, except with your consent, at your request, or as authorized to do so by law or by contract.

The Office of the Treasurer of the State of Connecticut administers the Connecticut ABLE program. The ABLE CT website is maintained and administered by Ascensus College Savings Recordkeeping Services, LLC ("Ascensus"). As an ABLE CT contractor, Ascensus provides program management, recordkeeping, account processing, and customer service directly to account owners in the ABLE CT plan.
