# Privacy Policy RI's ABLE

RI's ABLE is administered by the State of Rhode Island Office of the General Treasurer ("Treasurer's Office"). RI's ABLE recognizes, respects, and protects the personal privacy rights of all our customers. We are committed to providing the highest level of security and privacy regarding the collection and use of our customers' personal information.

## **Collection of Information**

We collect personal information about you from enrollment forms, other forms, correspondence, and other communications. We also collect information about you from transactions related to your account(s) and from the following sources:

- Information received from the Social Security Administration and Internal Revenue Service
- Information received from third party payment processors to which you have made contributions or withdrawals

Personal Information may include, but may not be limited to, your name, address, telephone number, Social Security number, Taxpayer ID, or email address.

### **Use of Information**

We do not disclose personal information about our current or former customers to third parties except as set forth herein, permitted by law, or with your consent. We may disclose all the personal information we collect from you to third parties as may be necessary to provide services related to RI's ABLE. Additionally, we may disclose some of your personal information with the Office of the Rhode Island General Treasurer's Unclaimed Property Division for purposes of reuniting you with property of which you may be the proper owner.
